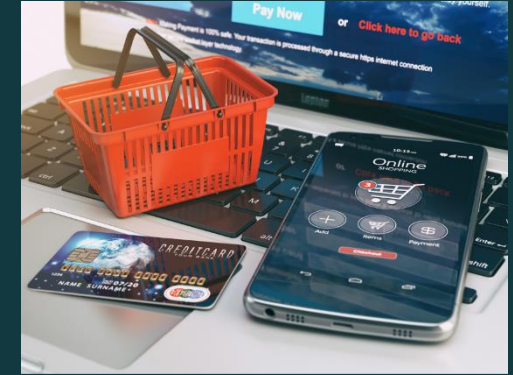

Time to market

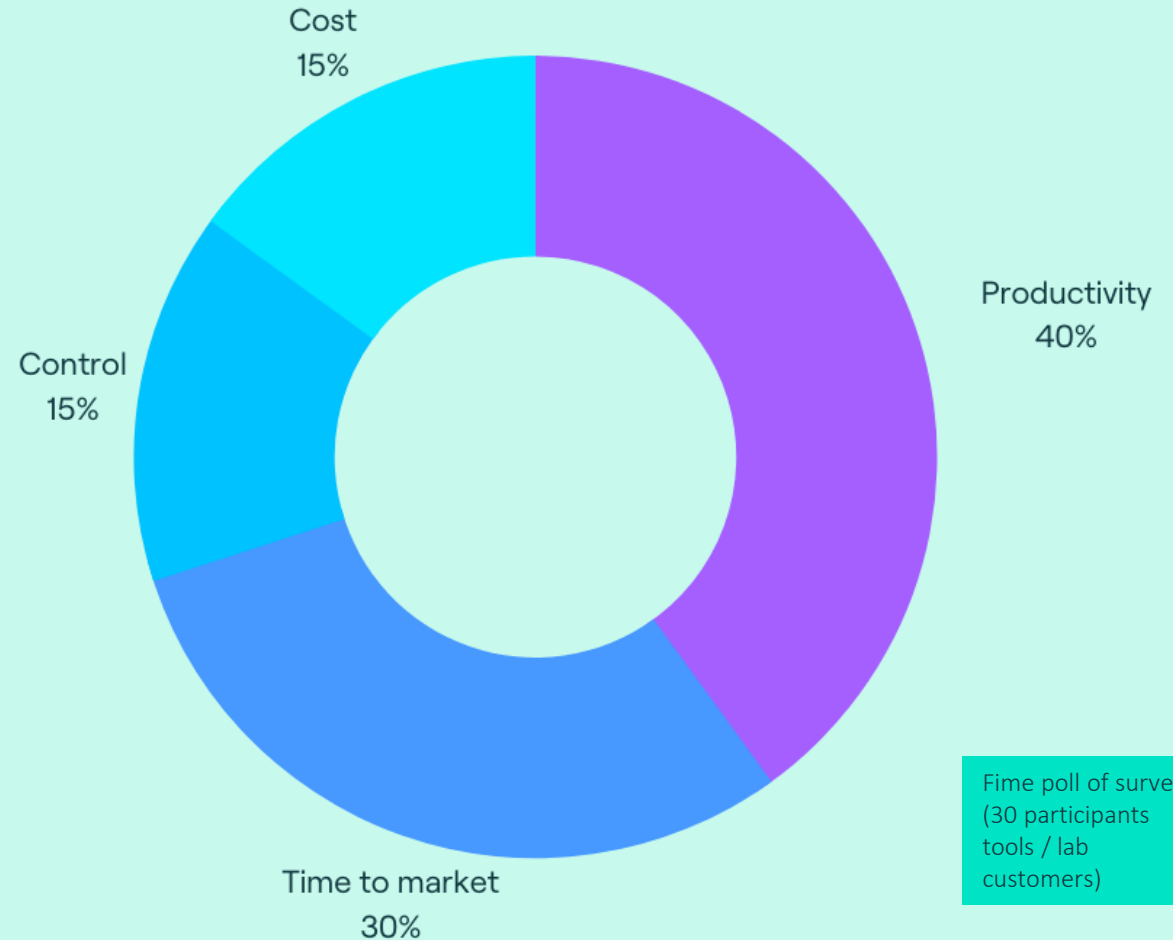

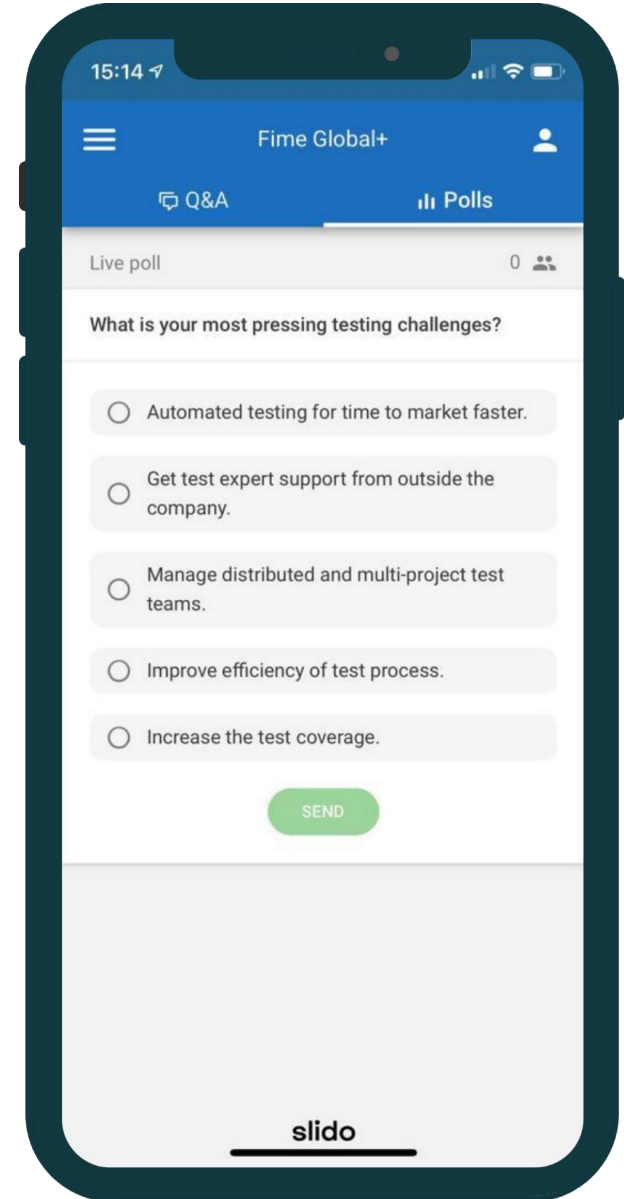
